**ORDER No. 12**

**MONTHLY MEETINGS WITH FLINT CITY COUNCIL**

BY THE POWER AND AUTHORITY VESTED IN THE EMERGENCY MANAGER ("EMERGENCY MANAGER) FOR THE CITY OF FLINT, MICHIGAN ("CITY") PURSUANT TO MICHIGAN'S PUBLIC ACT 4 OF 2011, THE LOCAL GOVERNMENT AND SCHOOL DISTRICT FISCAL ACCOUNTABILITY ACT, ("PA 4"); MICHAEL BROWN, THE EMERGENCY MANAGER, ISSUES THE FOLLOWING ORDER:

On March 16, 2011, the Local Government and School District Fiscal Accountability Act, Public Act 4 of 2011, ("Public Act 4") was enacted to safeguard and assure the fiscal accountability of units of local government; to preserve the capacity of units of local government to provide or cause to be provided necessary services essential to the public health, safety and welfare of citizens; and

Governor Rick Snyder appointed Michael Brown as the Emergency Manager for the City of Flint on November 28, 2011, and his contract was approved by the State Treasurer on November 29, 2011; and

Pursuant to Public Act 4, the Emergency Manager has broad powers in receivership to rectify the financial emergency and to assure the fiscal accountability of the City of Flint and its capacity to provide or cause to be provided necessary services essential to the public health, safety and welfare; and

Pursuant to Public Act 4, the Emergency Manager exercises solely, for and on behalf of the local government, all authority and responsibilities of the chief administrative officer and governing body concerning the adoption, amendment, and enforcement of ordinances or resolutions of the local government; and

Based on the foregoing, the Emergency Manager will conduct monthly meetings with Flint City Council to provide a status report and to answer Council members' questions. The meetings will be

open to the public and will provide an opportunity for public hearings, as scheduled by the Emergency Manager.

The meetings will be conducted on the second Monday of every month in City Council Chambers from 5:30 p.m. to 7:00 p.m. The City Council President will be the chairperson for the meetings. The agenda for the meetings shall be as follows, except when modified by the Emergency Manager:

1. Call to Order by the Council President
2. Roll Call by City Clerk
3. Pledge of Allegiance
4. Presentation of minutes
5. Report by Emergency Manager and/or his designee(s)
6. Council Questions & Answers
7. Closing Comments by Emergency Manager
8. Public Comment
9. Adjournment

All procedural questions concerning the meetings shall be addressed by the Emergency Manager.

If a member of the public wishes to address the City Council, they may do so at the prescribed time. He or she shall submit, prior to the start of the meeting, a statement in writing containing his or her name. A box will be placed at the entrance to the Council Chambers for the collection of the statements.

Members of the public shall have 5 minutes during public comment to be heard. There shall be one public comment period per person per meeting, with no extensions.

Any person attending a meeting may be called to order by the Council President or any councilperson for failure to be germane, for vulgarity, for personal attack of persons or institutions, or for speaking in excess of the allotted time. A person called to order shall thereupon take his or her seat until the Council President shall have determined whether he or she is in order. Every question of order shall be decided by the Council President. If a person so engaged in presentation shall be determined by the Council President to be out of order, that person shall not be permitted to continue at the same meeting.

This Order may be amended, modified, repealed or terminated by any subsequent order issued by the Emergency Manager.
