- To begin assessment for which previous strategies still align with residents.


What is a Comprehensive Plan and what is the process going forward?

- What is a comprehensive plan? The guide to a community's vision for future development
- Why is it important? The plan will help identify resources, needs, and goals, and help develop consensus.
- The comprehensive plan update process will take an expected 18 months and include at least 50 public meetings and other engagement events where all residents will be invited to contribute feedback and ideas, so today will not be the only opportunity for you to help shape our city's plan.

How your input will be utilized

- It also helps the team understand key areas of concern that still remain from the 2013 comprehensive plan

Housing & neighborhoods data update



Quick Data Points:

- 7.3% decrease in overall poverty
- Increases in both male (2.5%) and female (6.45%) single family households
- Decrease in total housing units available (-9,179)
- Decrease in occupied units (-6,973)
- Increase in occupied units (2.55%) and vacant units (3,121)
- Decrease in multi-family units (5,644)
- Decrease in household size (.26)
