

EDC/BRA Annual Report 2024

#### INTRODUCTION

The City of Flint Economic Development Corporation (EDC) and Brownfield Redevelopment Authority (BRA) are pleased to provide the following Annual Report showing its activities in calendar year 2024. The EDC/BRA is an appointed body that advises, supports, and approves an array of issues related to the development and businesses in the City of Flint.

### **PURPOSE**

The purpose or purposes for which the corporation is organized are as follows: To act as an economic development corporation in accordance with Act 338 of the Public Acts of 1974, as such statute may from time to time be amended; including particularly to alleviate and prevent conditions of unemployment, to assist and retain local industries and commercial enterprises, to strengthen and revitalize the economy of the State of Michigan and particularly the City of Flint, to provide the means and methods for the encouragement and assistance of industrial and commercial enterprises in locating and expanding in the State of Michigan and particularly in Flint, to encourage the relocation and expansion of commercial enterprises to more conveniently provide needed services and facilities of the commercial enterprises to the City of Flint and residents thereof. In furtherance of these purposes, the corporation shall have all of the powers which now are or hereafter may have conferred by law on corporations organized under Act 327, Public Acts of 1931, as amended, Act 284, Public Acts of 1972, as amended, and particularly the powers granted by Act 338, Public Acts of 1974, and especially section 7 thereof, to-wit:

- (a) Construct, acquire by gift or purchase, reconstruct, improve, maintain, or repair projects and acquire the necessary lands for the site therefore.
- (b) Acquire by gift or purchase the necessary machinery, furnishings and equipment for a project.
- (c) Borrow money and issue its bonds or notes to finance part of all of the cost of the acquisition, purchase, construction, reconstruction, or improvement of a project or any part thereof, the cost of the acquisition and improvement of the necessary sites therefor, and acquisition of machinery, furnishings, and equipment therefor, and the costs necessary or incidental to the borrowing of money and issuing of bonds or notes for such purpose.
- (d) Enter into leases, lease purchase agreements, or installment sales contracts with any person, firm or corporation for the use or sale of the project.
- (e) Mortgage the project in favor of any lender of money to the corporation.
- (f) Sell and convey the project or any part thereof for a price and at a time as the corporation determines.
